1. Benefit Categories and Reward Amounts:

2. Marriage:

- 2.1. Only the account holder is eligible to apply under this category.
- 2.2. In the event of both parties to a marriage being account holders, only one claim will be entertained.
- 2.3. All claims to be submitted within 3 months of the event.

3. Child Birth:

- 3.1. The funds should be credited to a “Tikiri A/c” in the name of the child. However BMGs are empowered to approve deviations for the disbursements depending on the credibility and potential of the customer.
- 3.2. In the event of both parents being account holders, only one claim will be entertained.
- 3.3. The rare occurrence of twins/triplets birth, customers will be entitled for multiples of the reward, however maximum amount that could be claimed is capped at Rs.40,000 which would need to be credited in equal values to their respective Tikiri A/cs.

4. Foreign employment bureau registration fee - (SLBFE):

- 4.1. The registration fee paid to the SLBFE could be reimbursed within 12 months of the payment.
- 4.2. Client to maintain the required balances as per section 1.

5. Surgery / Cataract Surgery:

- 5.1. Account holder or any member of the immediate family is entitled to claim under this category. **Locally (at a Private, Government Hospital Paying Wards) or abroad** will be considered for reimbursement of surgical expenses.
- 5.2. The grant for surgery will be offered as a reimbursement of surgery expenses and not for hospitalization without surgery, laboratory tests, costs of medicine, investigations etc.
- 5.3. Claim for dental surgery will not be entertained under this scheme.
- 5.4. For Cataract surgery only the cost of the **lens and accessories** will be reimbursed.
- 5.5. Amount will be reimbursed where supporting bills are provided and would be either the actual expenditure or the entitlement whichever is lower.

6. Holiday Package:

- 6.1. Free holiday package at a star class hotel will be given to the customers depending on their minimum balance maintained for a continuous period of six months
- 6.2. Qualified customers should submit their requests to the branch where they maintain their account.
