Terms and Conditions

1. General issues/ clarifications:

- 1.1. A minimum credit balance of Rs. 20,000/- is required to be maintained in any of the above accounts for a continuous **period of 12 calendar months** immediately preceding the date of the event.
- 1.2. Qualifying period will be calculated by **excluding the month** the event has occurred.
- 1.3. In the event of both caesarean surgery and child birth claims are submitted, both claims could be honored.
- 1.4. In the event customer maintains several accounts, **only one account** would be entertained per customer/per event.
- 1.5. Necessary documents should be submitted in order to receive grants and must be submitted **within 3 months** from the event.
- 1.6. Only one claim would be entertained per account holder under each category for a period of **365 days** from the date of event.
- 1.7. Customers who have obtained credit facilities against their savings and current accounts balances (full/partial) are not eligible to receive rewards under Seylan Sure scheme.
- 1.8. **Additional Rs. 5,000/-** will be added for each minimum of Rs. 50,000/- maintained after the balance of 150,001 and above. **.(Except 60th Birthday category)**
- 1.9. **Additional Rs. 2,500/-** will be added for each minimum of Rs. 50,000/- maintained after the balance of 150,001 and above for category of 60th Birthday.
- 1.10. 25% additional grant amount will be awarded to children of the customers who have a **Tikiri account with balance of 20,000/-** and above. (Applicable only for grade five scholarships)
- 1.11. All benefits will be entertained only for the normal saving and rupee current accounts, and high interest; minor accounts and special saving account will **not be included**.
- 1.12. In the event the customer is unable to submit originals of relevant documents (diagnosis card/ hospital bills) to the bank, customer should get the copies certified from the relevant hospital.
- 1.13. The amount granted where supporting bills are provided would be either the actual expenditure or the entitlement whichever is lower.
- 1.14. For Cataract surgery **only the cost of the lens and accessories** will be reimbursed.
- 1.15. In the event both parents being account holders, **only one claim** will be entertained.
- 1.16. This new scheme comes into effect from 1st August 2016.
- 1.17. The bank reserves the right to alter or cancel the scheme without prior notice.
