DECLARATION BY THE COMPANY

We the Company hereby agree and undertake that;

The provided details are true and correct and are given in support of our application to Seylan Bank PLC Sri Lanka ("the Bank") for a Credit Card account, subject to the respective Credit Cardholder Agreement which outlines the terms and conditions of use, and is available in www.seylan.lk (Bank's Website) and any subsequent amendments thereto which will be published in the Bank's website from time to time. We hereby accept and undertake to be bound by the aforesaid terms and conditions.

We hereby acknowledge and agree that it is the duty of ourselves and the Cardholder/s duly appointed by us, to be aware of and acknowledge ourselves of the said terms and conditions and the subsequent amendments in a timely and regular manner. We also agree that in the event of us refusing and/or not agreeing to the said terms and conditions we will immediately return the said Credit Card/s to Seylan Bank PLC. We further acknowledge that not returning the Credit Card by us would amount to our due acceptance of such terms and conditions and/or any amendments to terms and conditions applicable to Seylan Bank Credit Cards.

In the case of a Corporate Credit Card, Corporate Fuel Card or similar Card ("the Credit Card") shall be issued solely at the request of the Corporate entity ("the Company") and we the Company shall accept full responsibility for all transactions including withdrawal/ transfer/ payments made and shall be effected/processed with the use of the Credit Card with or without the use of the Personal Identification Number ("PIN") and we hereby authorize you to debit our Credit Card account with the amounts of all the charges associated with the issuance and usage of Credit Card inclusive of legal fees or other statutory charges, (if any).

We further authorize you to debit our said Credit Card account with all charges relating to transactions made internationally using the Credit Card and/or through any other local networks except the Bank's network (whenever applicable).

The Statement of Credit Card Account or other notifications relating to the Credit Card shall be sent to the Company. We acknowledge that it is our responsibility to review the Credit Card statement and to bring any issues and concerns in relation to the Credit Card statement to the Bank's notice within 30 days from the date of dispatching. The Bank shall not be held liable for any losses, costs, damages or claims incurred by the Company due to its failure to act in the manner herein stated.

We the Company do hereby consent to share the monthly Credit Card statement with the Cardholder/s.

Credit Card/s issued hereunder shall not be used by the Cardholder/s to purchase goods and services in commercial quantities both locally and internationally and to transfer capital out of Sri Lanka. We agree that any enhancement of the credit limits of Credit Card will be solely at the request of the Company by way of a fresh board resolution. We are aware that certain ATM machine/bank counter restrictions may apply to usage of the Credit Card/s in Sri Lanka and in overseas.

The Credit Card issued shall at all times remain the property of the Bank and shall be returned to the Bank unconditionally and immediately upon the Bank's request

As duly resolved by the Company, we the Company acknowledge that the Credit Card shall be used by the Cardholder/s only for official purposes, where the Company shall obtain acknowledgement/s from the Cardholder/s to such effect. Irrespective of the said restriction imposed on the Cardholder/s the Company shall accept full responsibility of all transactions of the Cardholder/s that shall be effected/processed with the use of the Credit Card by the Cardholder/s duly appointed by the Company.

Credit Card which shall be issued hereunder shall not be transferrable. It shall not be used for any purpose other than for transactions designated by the Bank.

The PIN requires to be kept strictly confidential by the Cardholder/s and also we have obtained an independent undertaking from the said Cardholder/s that such number shall not be revealed to any person at any time or under any circumstance.

The Cardholder/s shall use the Credit Card only up to the arranged limit available for the said Credit Card. Any Credit Card limit enhancement shall be considered by the Bank only at the sole request of the Company and granting such enhancement shall solely be at the discretion of the Bank.

The Bank's Credit Card statements and records of all transactions processed by the use of the Credit Card as conclusive and binding on us, the Company for all purposes.

If the Credit Card is stolen or lost or used without the authority of the Company or the Cardholder/s, we hereby accept and undertake that the Bank immediately be notified on same by the Cardholder/s which shall be subsequently followed by a written confirmation by the Company. We agree to accept liability of all transactions processed or effected using the Credit Card until reporting to the Bank of such loss, stolen, unauthorized usage of the card/s by the Cardholder/s.

In an event of failure either by the Cardholder/s or by the Company to act as stated herein, we hereby undertake and agree to accept full responsibility and liability for all transactions processed or effected with the use of the Credit Card howsoever affected thereby. At any event we shall not hold the Bank liable for such transactions and shall at all times keep the Bank indemnified for any losses, damages, costs, charges, expenses or any liabilities which may thereafter be suffered or incurred by the Bank and/or any actions, proceedings, claims, demands whatsoever which may thereafter be brought or made against the Bank by whomsoever or any detriment of whatsoever kind or nature which may arise in connection with the said Credit Card.

The Bank shall at any time be entitled to amend, supplement or vary any of these terms and conditions of the Credit Cardholder Agreement that shall be available in the Bank's website which shall become binding and applicable on the Company immediately thereafter. Additionally, the use of the Credit Card shall be subject to the Bank's prevailing policies, guidelines, rules, regulations and any terms and conditions governing Bank's services, facilities and transactions.

All the replacements and renewals of the Credit Card shall be subject to the terms and conditions which shall be in force at such time.

The Bank shall have the full discretion to cancel, withdraw or renew the Credit Card without any prior notice or assigning any reasons to us or to the Cardholder/s duly appointed by us. In the event of the death, resignation, retirement, removal, termination of services of duly appointed Cardholder/s or upon occurrence of any event of similar nature the Company shall submit seven (07) days' prior written notice of termination/cancellation of the Credit Card, together with a Company Board Resolution and forthwith return the Credit Card and shall obtain valid receipt thereof. We hereby undertake to surrender the Credit Card to Seylan Bank upon Company's liquidation, bankruptcy, acquisition, amalgamation and upon occurrence of any event of similar nature.

The Bank shall determine the privileges attached to the use of the Credit Card and shall have absolute discretion to charge, vary or amend these privileges and conditions attached thereto, from time to time, as the Bank deems fit.

The Bank shall direct us the Company and/or the Cardholder/s duly appointed by us to seek prior written permission from the Director - Department of Foreign Exchange, for any payment to a resident outside Sri Lanka through Credit Card for any purpose which falls outside the purview of directions No. 2 of 2017 of Foreign Exchange Act, No. 12 of 2017.
