authorise and request you to issue me a Seylan VISA/ MASTER Card (hereinafter referred to as "the Debit Card") and hereby agree to be bound by the following terms and conditions:

- 1. The Debit Card shall at all times remain the property of Seylan Bank PLC (herein after referred as "the Bank") and shall be returned to the Bank unconditionally and immediately upon the Bank's request.
- 2. The Debit Card is for my own personal use only. It is not transferrable. It shall not be used for any purpose other than for transactions designated by the Bank.
- 3. I shall keep my Personal Identification Number (PIN – Secret Number) strictly confidential and undertake not to reveal such number for any person at any time or under any circumstance.
- 4. I shall accept full responsibility for all transactions processed or effected by the use of the Debit Card howsoever effected.
- 5. I hereby authorise you to debit my account with the amount of any withdrawal/ transfer/ payment made by the use of the Debit Card with the use of my PIN, with or without my knowledge or authority.
- 6. I further authorise you to debit my account with all charges relating to transactions made internationally through the Debit Card or through any other local networks except the Bank's network, whenever applicable and also with any other liabilities inclusive of legal fees or other statutory charges, if any, relating to the use of the Debit Card.
- 7. At no time shall I use or attempt to use the Debit Card for withdrawal/ transfer or to effect transactions unless sufficient funds are available in my account/s. I agree that the Bank is under no obligation to honour my payment instructions unless there are sufficient funds in my designated account/s at the time of receiving my payment instructions.
- 8. If my account is a joint account, I shall be jointly and severally liable for all transactions arising from the use of the Debit Card.
- 9. I shall accept the Bank's records and statements of all transactions processed by the use of the Debit Card as conclusive and binding on me for all purposes.
- 10. If the Debit Card is stolen or lost I shall notify the Bank immediately and I shall also give in written confirmation to the Bank. I shall not hold the Bank liable for any loss incurred by the use of the Debit Card that is lost, stolen or used without my authority.
- 11. The Bank shall at any time be entitled to amend, supplement or vary any of these terms and conditions at its absolute discretion with or without notice to me and such amendment, supplement or variation shall be binding on me.
- 12. All the replacements and renewals of the Debit Card shall be subject to the terms and conditions which are in force.
- 13. The use of the Debit Card shall be subject to the Bank's prevailing memorandum of conditions, rules, regulations and any terms and conditions governing all services, facilities and transactions covered by the Debit Card or otherwise.
- 14. The Bank shall have the full discretion to cancel, withdraw, or renew the Debit Card without any prior notice or any reasons given to me. In the event that I decide to terminate the use of the Debit Card, I shall give the Bank not less than 07 days prior notice in writing and forthwith return the Debit Card and obtain a valid receipt thereof.
- 15. The Bank shall determine the privileges attached to the use of the Debit Card and shall have absolute discretion to charge, vary or amend these privileges and conditions attached thereto, from time to time, as the Bank deems fit.
- 16. The Bank shall direct cardholders to seek prior written permission on the Director – Department of Foreign Exchange, for any payment to a resident outside Sri Lanka through Debit Card for any purpose which falls outside the purview of directions No. 2 of 2017 under Foreign Exchange Act, No. 12 of 2017.
- 17. Cardholders to undertake to surrender the Debit Card to Seylan Bank upon migration or leaving Sri Lanka for employment abroad. Except in the event that the card is issued only against the funds lying to the Credit of a PFCA or a BFCA and on the basis that outstanding amounts are settled from inward remittances or transfers from foreign currency accounts.
